

SUMMARY PARAGRAPHS EXPLAINING OFFENDER'S ATTAINED SCALE SCORES

TRUTHFULNESS SCALE: MEDIUM RISK RANGE **RISK PERCENTILE: 64**
1st Offender Inventory scale scores are accurate. Yet, this person tends to be defensive and/or guarded. This defensiveness may be situation specific, i.e., a reaction to court and/or probation settings. Yet, there is a fine line between caution and recalcitrance or evasiveness. This is an accurate 1st Offender Inventory report.

ALCOHOL SCALE: MAXIMUM RISK RANGE **RISK PERCENTILE: 93**
Either alcohol abuse is out of control or this person is a "recovering alcoholic" (refer to item #94). If recovering, relapse risk is high. Recommendations: Alcohol-related counseling (outpatient or inpatient), chemical dependency treatment or intensive outpatient treatment. Review "recovering" item #94. Augment with mandatory AA meetings.

DRUGS SCALE: MAXIMUM RISK RANGE **RISK PERCENTILE: 91**
Many self-report indicators of drug use or abuse are evident. Check the client's answer to the "recovering" question #100. Serious drug-related problems are indicated. If recovering, relapse risk is high. Recommendations: Monitored outpatient or inpatient chemical dependency treatment. Supplemental attendance at Narcotics Anonymous (NA) or Cocaine Anonymous (CA). A serious drug problem is present.

ENTITLEMENT SCALE: MAXIMUM RISK RANGE **RISK PERCENTILE: 92**
High Risk (90 to 100th percentile) scorers believe they are "entitled", "have a right to" or "deserve" many of the things they want or value. "Entitlement thinking" is often used to rationalize non-achievement and failure. Recommendations: Group awareness or clarification of expectations, personal responsibilities and related consequences might be considered.

PEER PRESSURE SCALE: MAXIMUM RISK RANGE **RISK PERCENTILE: 94**
This Person's score is in the high risk (90 to 100th percentile) or problematic range. This individual is sensitive to peer pressure and responsive to it. Recommendations: Group counseling, e.g., Cognitive Behavioral Therapy (Aaron Beck) or Rational Emotive Therapy (Albert Ellis) might be considered. Peer pressure is problematic.

ANTISOCIAL SCALE: MAXIMUM RISK RANGE **RISK PERCENTILE: 93**
This client's score is in the high risk (90 to 100th percentile) range. Antisocial thinking, attitudes and behavior are indicated. Other elevated (70th percentile and higher) scale scores could exacerbate antisocial acting out. Changing attitudes is difficult and takes time. If no violent acts or arrests consider mandatory group counseling. If violent acts or arrests consideration of more intense supervision may be warranted.

SELF-ESTEEM SCALE: MAXIMUM RISK RANGE **RISK PERCENTILE: 91**
This individual's score is in the high risk (90 to 100th percentile) range. Very low and impaired self-esteem is evident. This client manifests pervasively negative self-evaluation, disapproval of self and negative expectations. Recommendations: Group counseling emphasizing self-acceptance, development of socialization skills, emotional support of endeavors and lifestyle adjustments.

SIGNIFICANT ITEMS: The following self-report responses represent direct admissions or unusual answers, which may help in understanding the offender's situation.
